Schedule C



LIMITED WARRANTY

- 1. This Limited Warranty is extended to the original purchaser of the Vessel at retail, and is not extended to any subsequent purchaser of the yacht. This Limited Warranty is not transferable. The obligations of NWY under this Warranty shall be further limited if the yacht is used for hire or charter. If the yacht is used for hire or charter, NWY, at its sole discretion, shall determine whether or not the requested repair is covered by this Limited Warranty or whether or not this Limited Warranty has been voided due to abuse, misuse or neglect caused by the hire or charter of the yacht.
- 2. This Limited Warranty applies to those components of the yacht manufactured by NWY or built by NWY contractors to NWY's design and exclusively for NWY. Components not covered under this Limited Warranty are: gel coat coloration, exterior finishes of hull, exterior superstructure, upholstery materials, minor cracking of exterior finish or checking of wood trim or teak decks. Engines, generators, electrical components, hoses, pumps, hardware, appliances, doors, windows, toilets and any items not specifically manufactured under the NWY brand are covered by their own individual manufacturer's warranties. Original Limited Warranty registration and validation cards are provided to Purchaser at delivery. All cards should immediately be filled out and signed as individually specified.
- NWY at shall determine whether a defect is warranted. NWY may require that the Vessel or defective parts be returned to the NWY or an authorized agent of NWY for repair or replacement. Limited Warranty repairs, replacements or expenses incurred must be authorized in advance by NWY.
- 4. Warranted components or repairs shall be covered by this Limited Warranty for 90 days following component replacement or completion of repairs.
- 5. NWY responsibility or liability through the failure of any Vessel or component extends solely to repair or replace the defective component.
- 6. It is a condition of this Limited Warranty that the Vessel has been given reasonable care. Modifications to the Vessel, accident, negligence, misuse or unauthorized alterations may negate coverage under this Limited Warranty.
- 7. NWY intends to continuously evolve its line of Northwest models and reserves the right to modify its products through changes in design and material without obligation to incorporate such changes in Vessels of prior manufacture or other Vessels under construction or Vessel that is subject to the agreement to which this Limited Warranty is in effect.

- 8. The duration of the Limited Warranty protecting the fiberglass structure, excluding the deck and all fittings and attachments to the hull, shall be one (1) year from the date of delivery. The duration of the Limited Warranty against osmotic blistering shall be three (3) years. The Limited Warranty covering the other NWY manufactured components as defined in paragraph 2 shall be for duration of one (1) year from the said date of delivery.
- 9. This Limited Warranty does not extend to any other damages that the original purchaser claims to have suffered by reasons of such defects.
- 10. NWY shall not be responsible for dockage fees or storage or for loss of use of the vessel while approved warranty repairs are being carried out.
